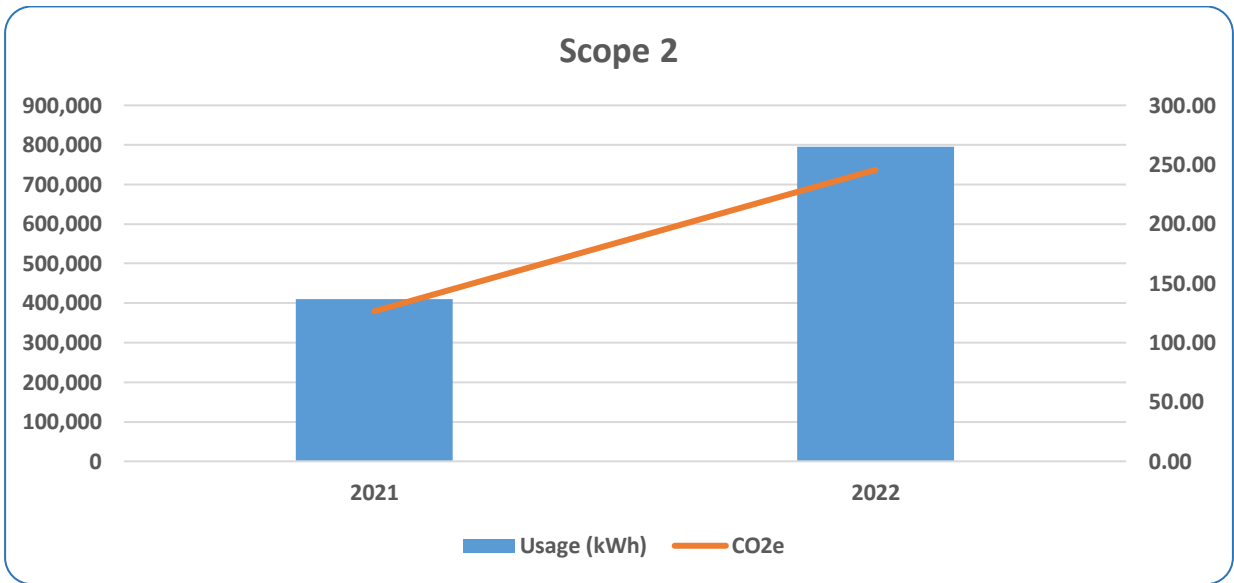

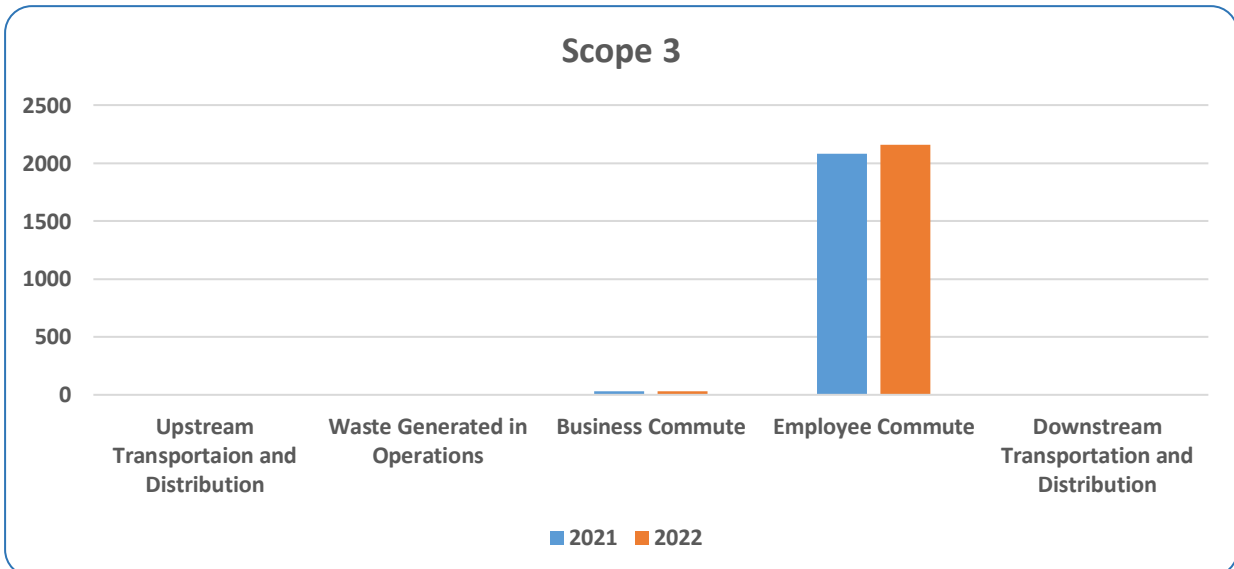

Increase seen is due to business growth and majority of staff returning to work in office.

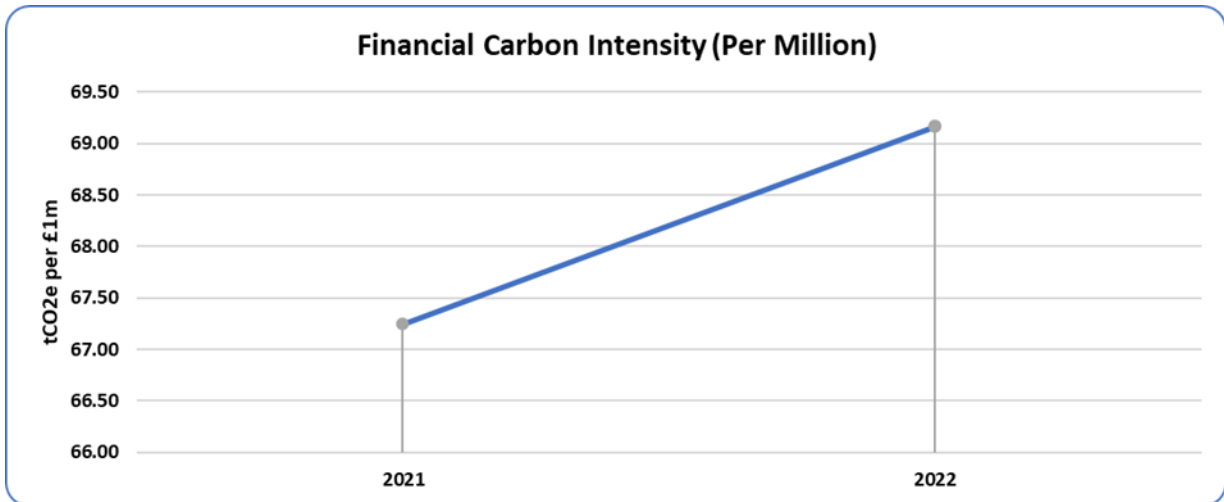

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline.

ResQ have already brought into action several measures, these include:

- All lights being replaced with LED Lighting
- Lighting controls such as Motion Sensor Technology
- Air Conditioning Controls have had their minimum and maximum ranges capped
- Air Conditioning Units on set timers
- Energy Efficient Air Conditioning Units

- Achieved and maintained certification with ISO14001

In the future we hope to implement further measures such as:

- The introduction of a cycle to work scheme
